INTRODUCTION

A recent global survey conducted by Gartner indicates that 26 percent of IT spending is outside of the traditional IT budget. This raises governance issues for board executives and integration issues for IT managers. Organizations therefore must have a clear IT Governance in place to ensure that the core IT services are ready to exploit the digital economy opportunities. Gartner defines "IT governance (ITG) as the processes that ensure the effective and efficient use of IT in enabling an organization to achieve its goals." Gartner makes two distinctions in IT governance: "IT demand governance (ITDG-what IT should work on) is the process by which organizations ensure the effective evaluation, selection, prioritization and funding of competing IT investments; oversee their implementation; and extract (measurable) business benefits. ITDG is a business investment decision- making and oversight process, and it is a business management responsibility. IT supply-side governance (ITSG-how IT should do what it does) is concerned with ensuring that the IT organization operates in an effective, efficient and compliant fashion, and it is primarily a CIO responsibility."


